HAZARDOUS WASTE DISPOSAL POLICY

Stavropol State Agrarian University in its waste management policy is guided by the provisions of Federal Law No. 7–FL of 10.01.2002 "On Environmental Protection", Federal Law No. 89–FL of 24.06.1998 "On Production and Consumption waste", SanPiN 2.1.7.1322-03 "Hygienic requirements for the placement and disposal of production and consumption waste" and other applicable regulatory legal acts, which define the legal basis for the management of production and consumption waste in order to prevent harmful effects on human health and the environment, the involvement of waste in economic turnover as additional sources of raw materials.

SSAU keeps records and controls the formation, collection, accumulation, transportation, reuse, disposal and disposal of waste. SSAU has signed an agreement with a regional operator for the removal and disposal of municipal solid waste (hereinafter referred to as MSW).

Compliance with the requirements in the field of MSW circulation is mandatory for all employees of SSAU.

All waste according to the degree of environmental impact is divided into the following hazard classes:

Class I — extremely dangerous;

Class II — highly dangerous;

Class III — moderately dangerous;

Class IV — low-risk;

Class V — practically non-dangerous.

The activities of the university departments are aimed at reducing the volume (mass) of waste generation, the introduction of waste-free technologies, and the conversion of waste into secondary raw materials.

At the University, production and consumption waste is collected at specialized sites, which are formed in the process of production, performance of works, provision of services or in the process of consumption, which are removed, intended for disposal or are subject to disposal.

SSAU does not have its own waste disposal and disposal facilities — specially equipped facilities designed for waste disposal.

Specialized containers for separate collection of MSW are installed on the territory of SSAU. Explanatory and educational work is being carried out among students and teachers of the university about the need for sorting and separate garbage collection.

In the autumn period, employees and students of the university hold subbotniks to collect fallen leaves, which are then transferred to the regional operator. Responsible employees of the university monitor the cleanliness of the university territory.

SSAU regularly monitors changes in regulatory legal documents of the federal and regional levels regulating activities in the field of waste management. In terms of research work, teachers and students of the university are working on the disposal of waste of animal and plant origin, followed by the production of complex organic-mineral fertilizers.

SSAU does not have waste of hazard classes I-II (biological, chemical, radiological, etc.), which have the potential to cause harm to people, animals or the environment both by themselves and by interacting with other factors, work with which requires licensing of activities.

In case of changes in the regulatory framework and delegation of additional powers to higher educational institutions in the field of waste management, SSAU is ready to expand the scope of its activities.
